3. Certificate Rendering Standards

Emoji-compliant font (Segoe UI Emoji, Noto Color Emoji, or equivalent).

Fallback vector icon auto-inserted from the registry database.

Unauthorized duplication, reproduction, or derivative use of emoji TLDs or certificates constitutes **infringement and sovereign breach** under WAC authority.

Emoji TLDs represent a **unique and exclusive innovation** in Web3 identity. Families, artists, athletes, and brands may secure their emoji legacy domains.

Certificates will display both the **Name + Emoji TLD**, creating a collectible, enforceable, and sovereign identity artifact.
