Enforcement Clause

All disputes, claims, or legal proceedings related to **tom.cruise** shall be resolved exclusively by the World Arbitration Court.

Failure by any party, institution, or government to comply with WAC rulings shall result in:

- Immediate blacklisting from Web4 banking and financial frameworks
- Freezing of associated blockchain assets
- Exclusion from BICRA-recognized trust and domain registries

Notary Verification

This Certificate further bears the **Blockchain Notary Seal**, verifying the authenticity of the domain's registration and binding it irrevocably to the WAC arbitration framework.

Key Implications

1. Collateralization – The crest/domain can be pledged as collateral in WTAA enforcement claims.
2. Lien Power – May be seized, assigned, or pledged in sovereign enforcement actions.
3. Jurisdictional Shield – All disputes are resolved exclusively by WAC jurisdiction.
4. WTAA Readiness – Asset tagged and admissible in enforcement datasets.
